Rights Issue Prospectus

Earth Heat Resources Limited ('Earth Heat' or 'The Company') is pleased to update shareholders and stakeholders on the lodgement today of a prospectus for the renounceable rights issue previously announced.

The Rights Issue will consist of a renounceable pro rata offer to shareholders to subscribe for three (3) new shares for every four (4) shares held at the record date with a one (1) free attaching option with a 0.5¢ strike and 31 January 2014 expiry ("Short Dated Option") for every two (2) rights shares subscribed, and a one (1) free attaching option with a 0.7¢ strike and 31 January 2016 expiry ("Long Dated Option") for every three (3) rights shares subscribed. The offer is fully underwritten by DJ Carmichael Pty Ltd.

A timetable and key dates summary is presented at the end of this release.

Managing Director of Earth Heat Mr Torey Marshall commented: "Following the engagement of corporate advisors and a major internal strategic review your Board is convinced that there are inadequate levels of market interest in the Australian geothermal sector for Earth Heat to persevere with a purely geothermal asset base, despite our view that Earth Heat's existing projects afford exceptional long term growth opportunity. A broadened energy asset mix will afford much better opportunities for our shareholders over the short and medium term, with longer term opportunity already in the portfolio. The rights issue is fully underwritten by DJ Carmichael Pty Ltd which is a very strong vote of confidence in the conclusions of the board and its relationship to the investment community as a whole. We have used evolution to survive and thrive in the current environment."
