# Letter of Interest received from Xstrata to Purchase ~50MWe Electricity in Argentina

- Initial allotment of approximately 50MWe with potential for further expansion in the future

- Subject to satisfaction and waiver of certain conditions precedent, the parties may enter into a binding power purchase agreement (PPA) contingent on Xstrata Copper's decision to advance development of the El Pachón Project post receipt of the Environmental Impact Assessment Approval.
- Parties will initiate a process aimed at developing a long term strategic relationship for the generation, supply and purchase of energy arising from and dedicated to their Argentinean projects
- Underscores the strong demand for power in Argentina a market where EHR is extremely well positioned
